*Serving: Allen, Auglaize, Hancock, Hardin, Mercer, Putnam, and Van Wert Counties*

- Offers a voice to senior citizens and those with disabilities, often when no one else is available to take a stand to protect their rights.
- Investigates residents' rights violations in nursing homes, assisted living facilities, adult care homes, and to home health recipients utilizing creative strategies to gain client directed resolutions.
- The staff of two covers seven counties, encompassing 1,583 square miles, 141 facilities and agencies, and over 5,600 nursing beds.
- Offers advocacy and information to the entire community regarding issues of importance affecting our senior and disabled neighbors. Topics vary and can be as serious as recognizing elder abuse, neglect, anti exploitation, or how to choose a nursing home, or explaining the difference between Medicaid and Medicare.
- Provides input to state and federal legislators in an effort to garner support and influence directives involving senior issues.
- Accepts applications, from volunteers, to assist in service provision. Successful volunteers will be trained to handle basic incoming calls and provide clients an assurance that their issue will be addressed in a timely manner.
